REGULAR MEETING

CALL TO ORDER

The Regular Meeting of the Milford Borough Common Council was held at Milford Firehouse located at 21 Water Street on February 5, 2024. The meeting was called to order by Henry Schepens, Mayor at 7:00PM.

PLEDGE OF ALLEGIANCE was led by Mayor Schepens.

SUNSHINE PROCLAMATION was read by Mayor Schepens.

As required by the Open Public Meetings Act of 1975, adequate notice of this meeting was provided on January 11, 2024 in the Hunterdon County Democrat and Express Times newspapers.

Notices were also posted on the bulletin boards both inside and outside the Municipal Building and at the Milford Public Library.

NEW BUSINESS

Mayor Schepens held a moment of silence in memory of Russell Heller.

UNFINISHED BUSINESS

Cannabis Sub-committee Report – Councilman Rehl and Councilman Gallos

Councilman Rehl presented to Council the regulations of operating a retail cannabis dispensary in the Borough. Councilman Rehl stated he went to the cannabis store in Flemington and surveyed the amount of people and the time the customers spent in the store. Most customers spent approximately 15 minutes in the store and there was a steady amount of customers.

Councilman Rehl open the discussion to Council members and Councilwomen LaFevre and Yager did not want the stigma of a cannabis dispensary in the Borough. Councilwoman Livingston had a concern of the possible odor from the store. Mayor and Council thanked Councilman Rehl for a thorough report.

Mayor Schepens reported that other municipalities are looking into dispensaries in their community and this maybe an opportunity for Milford's debt.

Curtis Paper Site - Update

Mayor Schepens reported that he attended a meeting on Friday, January 26th with Congressman Kean, NJ DEP, EPA and Hunterdon County Commissioners regarding the Curtis Paper site. The EPA stated there are high levels of PFAS at the site and they are looking for the ground water contamination source. Congressman Kean requested the EPA to address this issue as quickly as possible. Mayor Schepens stated he hopes the EPA will work in a more expedited manner to find

the contamination. The EPA will hold a CAG meeting early in April.

LEGAL AFFAIRS REPORT – TODD BOLIG, ESQ.

- Attorney Bolig reported he updated the job descriptions for the employees in the Borough.
- Attorney Bolig had a discussion with our Zoning Officer regarding the 111 Hillcrest Avenue property and the membrane ordinance from the Planning Board. Attorney Bolig stated we will put a hold on the membrane ordinance and relook at the ordinance at a later date.
- Attorney Bolig and Rob Martucci, Borough Engineer will be working on a fiberoptic ordinance.
- At the next Council meeting there will be a resolution presented to reinstate the late fees and interest on the Water and Sewer accounts.

<u>REPORTS FROM DEPARTMENT COMMISSIONERS</u> <u>**ADMINISTRATION/SAFETY – MAYOR HENRY SCHEPENS**</u>

- Mayor Schepens stated he attended a meeting with Councilman Rehl and Rob Martucci, Borough Engineer regarding open projects in the Borough. Mayor Schepens reported there were several other issues discussed: time and attendance records, job descriptions and comp time for exempt employees.
- Mayor Schepens advised Council that we need to move the Borough Hall to the Milford Public Library. The Borough Engineer has been asked to design a scaled down plan to move the Borough Hall employees to the library as soon as possible.

BUILDING & GROUNDS – COUNCILWOMAN LAFEVRE

Councilwoman LaFevre reported the following updates:

- 1. Riffles-Borough Park/York Road DEP permit has been approved and project will go to bid shortly.
- 2. Ballfield/Tennis Court waiting for DEP permit approval.
- 3. Library Gasline need to sign a no cost contract with the gas company. Rob Martucci is also working on pricing for the boiler conversion.
- 4. Borough Hall Roof Borough Engineer has estimated a cost of \$140,000 to replace the roof.
- 5. Bat Removal from Attic Borough has an agreement with Ehrlich Pest Control in amount of \$7,885.00. The removal will be completed in the Spring.

SOLID WASTE/RECYCLING – COUNCILMAN GALLOS

Councilman Gallos stated the first SWAC meeting is scheduled for February 14th.

ORDINANCES – FIRST READING

ORDINANCE NO. 975-2024

CALENDAR YEAR 2024

ORDINANCE TO EXCEED THE MUNICIPAL BUDGET APPROPRIATION LIMITS AND TO ESTABLISH A CAP BANK (N.J.S.A. 40A: 4-45.14)

WHEREAS, the Local Government Cap Law, N.J.S.A. 40A: 4-45.1 et seq., provides that

in the preparation of its annual budget, a municipality shall limit any increase in said budget to 2.5% unless authorized by ordinance to increase it to 3.5% over the previous year's final appropriations, subject to certain exceptions; and,

WHEREAS, N.J.S.A. 40A: 4-45.15a provides that a municipality may, when authorized by ordinance, appropriate the difference between the amount of its actual final appropriation and the 3.5% percentage rate as an exception to its final appropriations in either of the next two succeeding years; and,

WHEREAS, the Common Council of the Borough of Milford in the County of Hunterdon finds it advisable and necessary to increase its CY 2024 budget by up to 3.5% over the previous year's final appropriations, in the interest of promoting the health, safety and welfare of the citizens; and,

WHEREAS, the Common Council of the Borough of Milford hereby determines that a 3.5 % increase in the budget for said year, amounting to \$43,164.98 in excess of the increase in final appropriations otherwise permitted by the Local Government Cap Law, is advisable and necessary; and,

WHEREAS, the Common Council of the Borough of Milford hereby determines that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years.

NOW THEREFORE BE IT ORDAINED, by the Common Council of the Milford, in the County of Hunterdon, a majority of the full authorized membership of this governing body affirmatively concurring, that, in the CY 2024 budget year, the final appropriations of the Borough of Milford shall, in accordance with this ordinance and N.J.S.A. 40A: 4-45.14, be increased by 3.5 %, amounting to \$43,164.98, and that the CY 2024 municipal budget for the Borough of Milford be approved and adopted in accordance with this ordinance; and,

BE IT FURTHER ORDAINED, that any amount authorized hereinabove that is not appropriated as part of the final budget shall be retained as an exception to final appropriation in either of the next two succeeding years; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance as introduced be filed with the Director of the Division of Local Government Services within 5 days of introduction; and,

BE IT FURTHER ORDAINED, that a certified copy of this ordinance upon adoption, with the recorded vote included thereon, be filed with said Director within 5 days after such adoption.

RESOLUTION OF THE BOROUGH OF MILFORD AUTHORIZING MILFORD BOROUGH'S ENGINEER TO DESIGN A FLOORPLAN TO INCORPORATE THE BOROUGH'S

Administrative Offices Within the Milford Borough Public Library.

WHEREAS, the Milford Borough Common Council recognizes certain limitations with the functionality of the existing Milford Borough Hall; and

WHEREAS, the Council wishes to redress said limitations by moving the administrative offices contained in the current Borough Hall to the Milford Public Library building, a building maintained and owned by the Borough; and

WHEREAS, Milford's Common Council seeks to reconfigure the Library building to adequately and appropriately accommodate all of the administrative office and needs of the Borough which include but are not limited to the offices of the Borough Clerk, Borough Deputy Clerk, Borough

Chief Financial Officer, Borough Zoning Officer, Borough Tax Collector, Borough Tax Assessor, as well as appropriate meeting rooms and storage for all such administrative functions; and

WHEREAS, the Milford Borough Common Council has discussed and concluded that the Borough's needs in this endeavor shall supersede those of the Milford Public Library's needs, and that this undertaking should be completed without delay; and

WHEREAS, the Borough Common Council hereby seeks to have the Borough's Engineer, Robert Martucci, P.E., design a floorplan which will accomplish the goals of the Common Council in a cost-effective, expedited manner.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of Milford Borough, County of Hunterdon, State of New Jersey, as follows:

- 1. The Borough's Engineer Robert Martucci, P.E., may design a floorplan to enable the movement of the Milford Borough Hall and all the functions performed in the Borough Hall to the Milford Public Library Building with said newly created floorplan to consider, foremost, the Borough's needs.
- 2. The cost to undertake this redesigned floorplan design which will include architectural details and electrical plan but shall be exclusive of actual construction materials and labor, shall not exceed Ten Thousand Dollars (\$10,000.00).

NOW, WHEREFORE BE IT HEREBY FURTHER RESOLVED by the MILFORD BOROUGH COMMON COUNCIL that all aforementioned recitals are incorporated herein as though fully set forth at length.

RESOLUTION NO. RE2024-030

Resolution of the Borough of Milford Opposing both New Jersey Assembly Bill A-4 and New Jersey Senate Bill S-4251

WHEREAS, legislation is being considered by the State Legislature, A-4 and S-4251 (the "Legislation"), which will abolish the Council on Affordable Housing; reform the responsibilities of municipalities concerning the provision of affordable housing; and appropriate \$16 million for State costs relative thereto; and

WHEREAS, the Legislation would also establish a process whereby a municipality shall determine its own present and prospective fair share affordable housing obligation based on the formulas established in the Legislation and as calculated by three court-appointed obligation special masters, representing the northern, central, and southern areas of the State; and

WHEREAS, the Legislation requires that a municipality adopt its' obligation by binding resolution no later than January 31, 2025 in order to be assured of protection from a builder's remedy lawsuit through which a municipality may otherwise be compelled to permit development, when the fourth round begins; and

WHEREAS, if the municipality adopts a binding resolution, then the municipality's determination of its obligation would be established by default, without any approval, as the

municipality's obligation for the fourth round; however this determination is not final, for a challenge of the determination may still be filed with the Affordable Housing Dispute Resolution Program (the "Program"), which would then be required to facilitate the same; and

WHEREAS, the Legislation would also require that municipalities further amend its' housing element and fair share plan to comport with the municipality's obligation for the fourth round; and

WHEREAS, the Legislation would appropriate \$12 million from the State's General Fund to the Program and \$4 million to the Administrative Director of the Courts, but would result in an xindeterminate financial impact to municipalities, which have already expended significant funds on compliance with the current and prior affordable housing legislation imposed by the State; and

WHEREAS, the Legislation would impose a significant administrative and financial burden on municipalities in order to re-establish a new framework for the calculation of affordable housing obligations; and

WHEREAS, the governing body of the Borough of Milford strongly believes that the Legislation will result in a substantial detriment to the Borough of Milford and all municipalities, and an unnecessary burden on the Courts.

NOW, WHEREFORE BE IT HEREBY RESOLVED by the MILFORD BOROUGH COMMON COUNCIL that all aforementioned recitals are incorporated herein as though fully set forth at length; and

BE IT FURTHER RESOLVED, that the governing body of the Borough of Milford strongly oppose A-4 and S-425 and urge the Legislature to vote "NO" on the same; and

BE IT FURTHER RESOLVED that a copy of this resolution be sent to Senate President Nicholas P. Scutari, Assembly Speaker Craig Coughlin, Senator Douglas J. Steinhardt, Assemblyman John Dimaio, Assemblyman Erik C. Peterson, Governor Phil Murphy and the New Jersey State League of Municipalities.
